



Mr O Removals Privacy Policy 2023

At Mr O Removals, we are committed to protecting and respecting your privacy.

This policy explains when and why we collect personal information, how we use it, the conditions under which we may disclose it to others and how we keep it secure.

Our Privacy Policy was last updated on 25th April 2023, and any updates will be posted on our website.

WHO ARE WE?

For the purposes of GDPR the Data Controller is Mr O Removals. The business was formed in 2012 with the aim of providing a high service of relocation across the UK.

Mr O Removals complies with its obligations under GDPR, by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect the personal data.

OUTLINE OF THE PRIVACY POLICY

We are committed to protecting your privacy and this policy outlines what information we collect from you, how it is collected, why it is being collected, how it will be used and who it will be shared with. We do not sell your information to third parties and do not intend to do so in the future. We use the information collected about you for marketing purposes and to enhance your experience when visiting the site. We are registered with the GDPR (General Data Protection Regulation).

We are committed to doing the right thing when it comes to how we collect, use, and protect your personal data. That is why we have developed this privacy policy, which:

- Sets out the type of personal data that we collect.
- Explains how and why we collect and use your personal data.
- Explains when and why we share personal data within Mr O Removals
- Explains the rights and choices you have when it comes to your personal data.

We offer a wide range of products and services, so we want you to be clear about what the Policy covers. This policy applies to you if you use our services (referred to as 'our Services').

HOW DO WE COLLECT INFORMATION FROM YOU?

We collect and use your personal information in accordance with this Privacy Policy.

We can get your personal information when you.

- Buy a product or service from us.
- Ask us for more information about a product or service or contact us with a question or complaint.
- We may also use the information we collect to send you our monthly newsletters. If you would rather not receive this information, you may opt out by unsubscribing to the mailing at any time.

We also monitor customer traffic patterns and site usage to help us develop the design and layout of the site.

WHAT TYPE OF INFORMATION IS COLLECTED FROM YOU?

The information we may collect about you depends on the products and services you use and subscribe to. It could include the following:

- Your name, address or location, telephone number, IP address, gender, company name and email address.
- Information enabling us to provide products and services to assist you in your relocation.
- Credit or debit card information, information about your bank account number and sort code or other banking information.
- Your contact with us – such as a note or recording of your call you make to one of our offices, an email or letter you send to us or other records of any contact you have with us.

We will also get information on how you use our products and services, such as:

- The phone numbers that you call or send messages to (or the phone numbers that you receive these calls and messages from).
- The date, time and length of the calls and messages you send or receive through our network, and your approximate time these communications take place.

We review our retention periods for personal information on a regular basis. We will hold your personal information on our systems for as long as is necessary for the relevant activity.

HOW DO WE USE YOUR PERSONAL INFORMATION?

We may use and analyse your information to:

- Keep you informed generally about new products and services via our monthly newsletter (unless you choose not to receive future marketing messages)
- Respond to any questions or concerns you may have about using our products or services.
- Prevent and detect fraud or other crimes, recover debts or trace those who owe us money.

We will store your information for as long as we have to by law. If there is no legal requirement, we will only store it for as long as we need it. We will also keep some personal information for a reasonable period after your contract has finished – just in case you decide to use our services again.

SHARING YOUR PERSONAL INFORMATION

We may share information about you with:

- Partners or agents involved in delivering the products and services you have ordered or used.
- Debt collection agencies or other debt recovery organisations.
- Law enforcement agencies, regulatory organisations, courts, or other public authorities if we have to, or are authorised to by law.

We will not share any of your personal information to any Third-Party Service Providers.

HOW DO WE PROTECT YOUR INFORMATION?

As required by GDPR, we follow strict security procedures in the storage and disclosure of information which you have given us, to prevent unauthorised access. Our security procedures mean

that we may occasionally request proof of identity before we are able to disclose sensitive information to you.

YOUR CHOICES

You have a choice about whether or not you wish to receive information from us. If you do not want to receive digital marketing communications from us, then you can select your choices by ticking the relevant boxes situated on the form when we collect your information.

You can choose to opt out of all marketing communications or to opt out of marketing in one of several ways (such as email).

We will not contact you for marketing purposes by email, phone, post, or text message unless you have given your prior consent.

YOUR PRIVACY RIGHTS

You can write to us at any time to get a copy of the personal information we hold about you. You can do this by filling in the contact us form available on our website, or email at info@mr-o-removals.co.uk

If you believe we are holding inaccurate information about you, please contact our customers service team so we can correct it.

You have the right to ask for a copy of the information Mr O Removals hold about you (we may charge £10 for information requests) to cover our costs in providing you with details of the information we hold about you.

COMPLAINTS AND CUSTOMER SERVICE POLICY
